

Queensland Funding Strategy – recap on Leadership Forum discussions

Service Delivery funding

If the funding remained the same:

general agreement that the same allocation be made to funded CLC without a tender process with the ability to renegotiate targets as the staffing does not buy the same services

If there was an increase to funding for unspecified purposes:

No consensus, but some support for general uplift to ensure sustainability of the existing service system; (sustainability is expansive – wage gaps, RRR costs, CLASS replacement, other rising operational costs)

Once sustainability has been achieved support for evidence-based decisions making, driven by legal need and CLCs being able to make the case for additional services



Queensland Funding Strategy 2025-2030

Feedback about:

- Service Delivery funding is the broad approach to status quo funding and new funding still aligning with your thinking?
- Non-service delivery funding:
 - Should funds be set aside for sundry items, projects, contingency purposes
 - If some cost are not paid for centrally, how would individual CLCs cover the costs?
 - Do we get value for money on EAP?
 - CLCQ's budget relies on project funding is this optimal?

Advocacy messages

- CLC needs funding security at least a guarantee of a maintenance of baseline funding under the new funding arrangements to secure the workforce, even if other aspects of the agreement are not settled
- Queensland election makes timing of funding processes difficult and risks there not being a 6 months notice of change in funding
- There is a workforce crisis in CLCs and this is exacerbated by a wage gap of 22% compared with Legal Aid
- CLCs need to make workforce plans as early as January 2025 to meet their obligations to their workforce

NLAP Review

The review report was delivered by Dr Mundy to the Federal Attorney-General on 6 March 2025.

State governments also have the final report.

The report should be publicly available within 3 months on completion of the review, unless it is not reasonable, appropriate or practical to do so at the time.

Given the consultation focus, we would expect there will be significant recommendations about workforce, amongst other things.

May 2024 Federal Budget

Nationally:

- \$9.3 million for CLCs in total
- \$2.4 million for indexation on NLAP funding but not all, based on 4% indexation
- \$6.9 million to assist in reducing pay parity
- No indication of funding commitment beyond June 2025 in forward estimates
- Federal A-G still considering the NLAP review report
- Queensland: (still unfolding)
 - based on previous distributions under NLAP, Qld might expect to see approximately 20% ie. >\$2mill

Scenario: State Budget

State budget doesn't deliver any extra funding in 2024-2025 for CLCs

What are the messages - External?

- Disappointed that the State budget didn't provide funding increases and urge the next Queensland government to provide extra funding under the new national mechanism
- The funding crisis in CLCs needs to be addressed by Government now
- Time is running out for Queensland CLCs

What are the strategies - External?

- Talk to government behind closed doors
- Talk to the LNP as the possible next government and get an election commitment
- Run a media campaign about the crisis in CLCs



Scenario: State Budget

State budget doesn't deliver any extra funding in 2024-2025 for CLCs

What are the messages - Internal?

- Disappointed that the State budget didn't provide funding increases, but nothing changes
- Jobs are secure until June 2025
- We will continue to fight for our community to get the services that it deserves

- Keep staff update to date with any changes
- Worst case scenario plan
