AND THEN..



We agreed to meet semi-regularly online through the year to keep yarning:

fairly informal, a space to collaborate and discuss issues we were coming across.

This was the beginning of what would become a community of practice.



Common issues identified:

- Conflicts, choice, lack of clarity about where community could get help
- Confusion about services and importance of choice
- Need to remove the 'black community legal aid' mash up

AND THEN..



Whichway is about doing things our way and an opportunity to showcase a best-practice model of First Nations way of knowing, being and doing.

We continued to meet regularly, not rushing the process, and allowing time and space for yarns and relationships to continue to develop.



ATSILS took the project lead, we added other identified key stakeholders and content experts and finalised the key topics for our first tranche.

ATSILS applied for a small grant through DJAG and worked on coincidentally bumping into key stakeholders in the funding space with his elevator pitch ready. Graham worked with Gilimba Creative to draft some resources with input from the group.

The WHICH WAY project team have worked closely with Gilimba creative agency to create 21 resources informing people about support options when they're facing child safety or domestic and family violence:
